FIVE CONDITIONS OF COLLECTIVE IMPACT

1 BACKBONE SUPPORT		Creating and managing collective impact requires a separate organization(s) with staff and a specific set of skills to serve as the backbone for the entire initiative and coordinate participating organizations and agencies.
2 COMMON AGENDA	Ś	All participants have a shared vision for change including a common understanding of the problem and a joint approach to solving it through agreed upon actions.
3 MUTUALLY REINFORCING ACTIVITIES	\bigcirc	Participant activities must be differentiated while still being coordinated through a mutually reinforcing plan of action.
4 SHARED MEASUREMENT	B	Collecting data and measuring results consistently across all participants ensures efforts remain aligned and participants hold each other accountable.
5 CONTINUOUS COMMUNICATION	Ç	Consistent and open communication is needed across the many players to build trust, assure mutual objectives, and create common motivation.



PRISON & ENTREPRENEURSHIP PROGRAM

Prison Entrepreneur Programs

Empowerment through Education

- 70% reduction in reoffending rates due to business education.
- 85% of participants reported feeling more prepared for post-release life

Business Acumen Development

- Participants' businesses showed a 30% increase in revenue in Year 1.
- 92% of inmates developed enhanced problem-solving skills.

Confidence and Self-Efficacy

- 88% of participants reported improved self-confidence.
- 95% expressed a positive shift in their long-term outlook.

Reduced Recidivism

- Paricipants engaged in entrepreneurial ventures are 50% less likely to reoffend.
- \$2 million saved annually in correctional costs.

Community and Networking

- 65% of participants formed lasting business connections.
- 81% reported a stronger sense of community support.





PRISON & ENTREPRENEURSHIP PROGRAM

Entrepreneur Incubator Programs

Holistic Skill Development

- 40% increase in successful business launches compared to nonparticipants.
- 87% developed proficiency in critical business areas.

Real-World Experience

- 75% of startups launched from incubators sustained for 3 years or more.
- 95% reported a better understanding of market dynamics.

Access to Resources

- Incubator-supported startups attracted \$1.5 million in funding on average
- 78% of participants accessed new funding sources.
- 82% of entrepreneurs demonstrated improved adaptability and problemsolving.
- 90% reported higher levels of resilience and determination.

Networking and Collaboration

- 67% established partnerships with experienced mentors. Collaborative ventures resulted in a 25% increase in revenue growth.
- 55% of incubator graduates initiated community-oriented projects.
- \$3.8 million contributed to local economies through these projects.
